# Children's and Young Persons Advocate

The Domestic Violence Prevention Centre GC Inc. (DVPC) is currently seeking applications from individuals who are suitably qualified and/or experienced in the delivery of support to children and young people who have experienced domestic and family violence.

The position is for 12 months and is located at the Southport office. The successful applicant will work with children and young people between the ages of 4 and 18 who have experienced domestic and family violence within their family or in their own intimate relationship to deliver trauma informed, age appropriate responses, either individually or in a group setting.

DVPC is a specialist Domestic and Family Violence (DFV) service based on the Gold Coast and Beenleigh. It provides domestic and family violence responses to women, children and young people and delivers the Men's DV Education and Intervention program in partnership with Queensland Corrective Services. DVPC currently has four sites of service delivery; and offers services from Beenleigh to the border of New South Wales.

AWARD/ CLASSIFICATION	Level 4 SCHADS Award (Qld) Social and Community Services Employee. The Pay point will be dependent on the successful applicant's skills and experience. This will be negotiated with the successful applicant prior to the issuing of the employment contract.
ANNUAL LEAVE:	5 weeks per annum (FTE)

- Permanent Appointment in this role is conditional on satisfactorily completion of a six-month probationary period

**THE ORGANISATION:** The Domestic Violence Prevention Centre GC Inc. (DVPC) is a specialist domestic violence service based on the Gold Coast and has been operating since 1992. It offers support to women, young people and children who have experienced domestic and family violence and delivers mandated behaviour change programs to male perpetrators of violence. DVPC utilises a feminist framework and evidence-based practice to inform and direct its service responses. DVPC convenes the GC Domestic Violence Integrated Response (GCDVIR), which brings together systems agencies and relevant organisations to improve responses to high risk women and children to enhance their safety

and wellbeing, and to actively work towards improving collaboration between all agencies on the Gold Coast who are responding to domestic violence.

**PURPOSE OF THE ROLE:** This position is funded under the Children's Counselling Service Type (T315). The position will work with children and young people to deliver age appropriate responses either individually or in a group setting. The support may be provided in locations other than the DVPC office.

Counselling and supportive activities with children and young people aims to support them to express their feelings and assist them to understand and manage their fears, emotions and behaviours. This service delivered to child and young person is in response to the domestic and family violence in which they have been exposed to and aims to break the cyclical and intergenerational nature of domestic and family violence.

Whilst this role is directly responsible to the Women and Children/YP Services Coordinator (WCSC), the role will be provided mentoring and guidance from experienced workers in the CYP Team.

All activities will be delivered in accordance with the Service Agreement, the DFV Investment Specifications relating to Children's Counselling Service Type (T315) and the internal processes, practices, policies and procedures of DVPC.



## **KEY ELEMENTS OF THE POSITION**

### Function 1. - SUPPORT, RESPONSE and COUNSELLING:

- Provide timely and appropriate responses (via telephone counselling, face to face or virtually) to children and young people and/or their carer who contact or are referred to the Program for support, information and referral
- Complete a comprehensive intake pertaining to the risk and safety for children and young people with themselves directly when age appropriate, or with their carer who has contacted DVPC or has been referred to the service
- Delivery age appropriate and proven effective modalities to children and young people who have experienced domestic and family violence

- Assess the appropriate response to the self or other referral, and make relevant referral pathways if required
- Provide information and referrals about supports available within the broader community and service system
- Provide advocacy with other service providers and systems stakeholders when necessary to achieve positive outcomes

# Function 2 - COMMUNITY AND STAKEHOLDER ENGAGEMENT AND PARTNERSHIP DEVELOPMENT

- Work appropriately with existing services and agencies to provide support to children and young people who have experienced domestic and family violence.
- Establish and maintain positive working relationships across a range of community agencies.
- Represent the Organisation at relevant community activities and events as requested

#### Function 3 - ORGANISATIONAL ACCOUNTABILITY, DEVELOPMENT and SUPPORT

- Maintain clear, concise, accurate client case notes and records that align with DVPC processes and practice guidelines.
- Collect performance data and prepare monthly reports including performance against service agreement deliverables and budget allocations
- Participate in the identification of pattern/trends to inform appropriate service development both formally and informally
- Prepare and engage actively in individual and/or group supervision for practice development
- Assist in the preparation of OASIS reports to the funding body
- Participate in activities for Domestic & Family Violence Prevention Month, IWD and the 16 Days of Activism and other activities in the community and related events
- Operate in compliance with Organisational guidelines, policies and strategic plan
- Contribute to the development of a professional and supportive working environment for all staff.
- Consciously create a workplace culture that is consistent with the DVPC's mission, vision and values

## **KEY SELECTION CRITERIA**

- KSC 1 Demonstrated experience working with children and young people with high and complex needs and an understanding of the issues and challenges in responding to these needs.
- KSC 2 Demonstrated experience or willingness to obtain the skills to support children and young people who have experienced complex domestic and family violence including an understanding of DV dynamics and risk assessment and the provision of appropriate crisis/therapeutic counselling and case management
- KSC 3 Ability to provide brief solution focussed crisis interventions and ongoing case managed support by utilising a number of proven effective modalities within an established practice framework.
- KSC4 Well-developed professional verbal and written skills
- KSC 5 Experience in using a client database and proficiency at record keeping and case noting
- KSC6 Demonstrated experience of developing and maintaining strong networks and partnerships within the broader service sector.
- KSC 7 Demonstrated competency of collecting data and preparation of reports on performance including outputs and outcome measures.
- KSC 8 Demonstrated capacity to work both independently and as part of a team.
- KSC 9 A working knowledge of current legislation relevant to the protection of victims of domestic and family violence and a working knowledge of the Family Law and Child Protection Acts.
- KSC 10 An ability and commitment to creating a positive work environment and strong organisational culture while contributing to the development and achievement of the goals and vision of the Organisation
